

## Marc Robinson: Consulting Track Record



Dr. Marc Robinson is a senior consultant who specializes in public finances – and more specifically, in public financial management (PFM), fiscal policy, performance management and expenditure policy. Before becoming a consultant, he was a staff economist in the Fiscal Affairs Department of the International Monetary Fund (IMF) and, earlier on, a senior civil servant and professor of economics in Australia. Marc is a member of the OECD Advisory Panel on Budgeting and Public Expenditures, and also of the Public Finance Advisory Panel of [ODI Global](http://odi.global). Dr. Robinson has worked with finance and other key ministries in many countries – ranging from European Union members to middle and low-income nations – to:

- Design, implement and improve performance budgeting and management systems,
- Develop effective spending review systems,
- Enhance performance monitoring and evaluation,
- Improve budget preparation processes more generally, including in areas such as medium-term budgeting, top-down budgeting and capital budgeting,
- Improve fiscal policy and fiscal transparency, and
- Develop and implement public financial management (PFM) reform strategies.

Marc has provided substantial advisory services in the Gulf region. This has included several major long-term consultancies for the Abu Dhabi Ministry of Finance to reform budget preparation processes and to design and implement systems for performance budgeting. As part of these engagements, he prepared a comprehensive budgeting manual for Abu Dhabi, including detailed sections on the overall process, the budget calendar, ceilings setting, capital budget, spending review and performance budgeting. He also undertakes advisory work for the Government of Saudi Arabia on a range of issues including the development of a spending review system and medium-term budgeting.

Dr. Robinson's many consultancy engagements for the World Bank include several years as Chief Technical Advisor to the World Bank-managed PFM Analytic and Advisory Assistance program in Vietnam. In this role, he oversaw strategy and implementation for the World Bank's Vietnam PFM reform program, including fiscal policy, budget preparation, budget execution, accounting and financial reporting.

Other World Bank consultancies he has undertaken include: Algeria (performance indicators); Azerbaijan (performance budgeting); Bangladesh (led independent review of World Bank-managed multi-donor PFM reform program); Belarus (budget reform); Brazil (spending review); Guatemala (Public Expenditure Review); India (PFM reform strategy and program classification) Indonesia (spending review and

improvement of parliamentary budget process); Poland (fiscal rules, spending review, medium term budgeting and performance budgeting); Romania (capital budgeting); Russian Federation (spending review South Africa (performance budgeting); Turkey (building evaluation as part of a program budgeting system); and Vietnam (leadership of the PFM component of Public Expenditure Review).

As a consultant to (and previously as a staff member of) the IMF, Marc provided technical assistance to a wide range of countries – ranging from Haiti to Italy – on performance budgeting, medium-term budgeting, fiscal policy, PFM reform strategy, and other aspects of budgeting reform. He undertook extensive technical assistance work for East African governments covered by the IMF's East Africa Regional Technical Assistance Center (East AFRITAC) over the period 2010-2014 (and has worked in twelve sub-Saharan African countries in total over the years). More recent missions undertaken on behalf of the IMF include Egypt (top-down budgeting and program budgeting) and Malaysia (spending review).

For the OECD, Marc has over the years prepared three influential commissioned papers – on public finance challenges in the post-COVID era (2022); spending review processes (2013); and PFM reform in OECD countries (2015). In 2011, he was a member of the OECD team that advised the Chilean Ministry of Finance on budgeting reform, and in 2024 of a team advising Greece on spending review and performance budgeting.

Dr. Robinson has also undertaken several projects for the Asian Development Bank and the Inter-American Development Bank. These include advise to the Ministry of Finance of the Government of Armenia on PFM reforms and the development of a government evaluation system.

He was also during 2002-4 a member of the Technical Advisory Panel, Financial Management and Accountability, African Capacity Building Foundation.
